

AGE DETERMINING:

AAU's Eligibility Rules will apply.

- GAME GUARANTEE:** Minimum of (3) Games. A team's 3rd game may be in pool or bracket play.
- GENERAL RULES OF PLAY:** 2013-2014 National Federation of State High School Associations (NFHS) rules apply. Ties in round robin play will be broken based upon head-to-head competition. Three way times will be determined by plus scores among the three teams.
- TEAM ROSTERS:** Rosters are due at team check-in and must be complete. Team coach is responsible for collecting birth certificates/documents. These documents must be made available to the Tournament Director upon request. No additions or changes during the tournament are permitted.
- CHECK-IN:** Teams are required to check-in on Saturday, February 22, 2014 between 7:00am – 8:00am at Daniel Morgan Middle School Gymnasium.
- UNIFORMS & EQUIPMENT:** Teams listed first will be "home teams". Designated home teams will wear white jerseys and visitors will wear dark jerseys. Game and practice balls will be provided at each gymnasium.
- GAME FORMAT:** Games will consist of (4) seven-minute quarters. Any first overtime period will be (3) minutes and any subsequent overtime will be 1 minute.
- TIMING & SCORKEEPING:** Each home team must provide an adult scorekeeper to maintain the official book for that game. Home scorekeepers must sit at the head table. Visiting teams must provide the timekeepers for each game.
- CONDUCT:** Only coaches and team members listed on the official roster are allowed to sit on the bench. Only (1) coach can be standing. The Head Coach is responsible for the conduct of the coaches, players and team fans. Disruptive behavior will result in the ejection from the tournament and can lead to the removal of the team.
- AWARDS:** Team awards will be given to the 1st place team in each division.
- FACILITIES & LOCATIONS:** Tournament games will be played at Daniel Morgan Middle School in the primary and secondary gymnasiums.

GATE ADMISSIONS:

Gate admission will be charged for all spectators. Players wearing team uniforms will be allowed entry to all game locations. \$5.00/person, children 3 and under are free.

TEAM EXPECTATIONS:

Teams should arrive at the gymnasium at least 30 minutes before their scheduled game.

Teams should have white (home) and dark (away) uniforms.
