

## ASBESTOS INSPECTION and ABATEMENT CERTIFICATION

Effective July 1, 1993, the Virginia Uniform Statewide Building Code requires all buildings to be renovated or demolished be inspected for the presence of asbestos-containing materials with appropriate response actions undertaken, subject to exemptions. The following form is to be completed by all applicants for Building Permits for renovations or demolition. A completed form will contain one box checked below and must be signed by the owner or authorized owner's agent.

☐ The above building is a single-family dwelling, or is a residential housing building containing four or fewer units, and asbestos inspection requirements. NOTE: This exemption does not apply if the proposed renovation or demolition is for opublic development purposes; or	
☐ The combined amount of regulated asbestos-containing material involved in the renovation or demolition is less than 2 pipes, or less than 160 square feet on other facility components, or less than 35 cubic feet off facility components where I could not be measured previously, and is exempt from asbestos inspection requirements.

If none of the boxes above have been checked, and if the building permit application is for repair or replace roofing, floor covering, or siding materials and the use is not a school, then asbestos inspection requirement satisfied by checking one of the following two boxes:
