It is expressly understood and agreed that THE WINCHESTER SHERIFF'S OFFICE PROJECT LIFESAVER makes no warranties of any kind with regard to the equipment described herein, the operation or effectiveness of the equipment described herein, the fitness or suitability of the equipment described herein. Moreover, THE WINCHESTER SHERIFF'S OFFICE PROJECT LIFESAVER is not responsible for the safety or welfare of the DESIGNATED WEARER of the PROJECT LIFESAVER bracelet and makes no guarantees whatsoever or warranties of any kind that they will be able to monitor, respond, track, locate or find any DESIGNATED WEARER of the PROJECT LIFESAVER bracelet discovered missing from the RESPONSIBLE PARTY'S care.
- 7. In the event of failure of the equipment described herein, THE WINCHESTER SHERIFF'S OFFICE PROJECT LIFESAVER will attempt to replace or repair such equipment at its option, upon being notified of the need for such service.
- 8. It is specifically agreed and understood that THE WINCHESTER SHERIFF'S OFFICE PROJECT LIFESAVER shall retain all title and interests in said equipment, and in no way does the RESPONSIBLE PARTY or DESIGNATED WEARER of the PROJECT LIFESAVER bracelet acquire any title in said equipment.
- 9. This agreement may be terminated at the option of either party upon seven (7) days written notice to the other party.
