

**Self-Assessment for APS Position
Winchester Department of Social Services (WDSS)**

The presence of a consistent, dedicated adult protective services worker has a positive impact on community and the protection of the elderly and adults with disabilities. Staff turnover interferes with the continuity and quality of services. Thus, it is important for those considering a career in adult welfare to carefully evaluate their own personal characteristics and to understand the work as well.

This self-assessment is designed to provide you with additional information about whether a position in adult welfare is for you. The items are related to employees' intentions to remain employed in adult welfare. An honest self-assessment can help you make an informed decision about whether employment in adult welfare is right for you.

In rating each self-assessment item, reflect carefully on your own personal characteristics and professional career goals as a potential employee in adult welfare. Be as honest as you can in your ratings of each item. Use a pencil or pen and paper and record your numerical rating for each self-assessment item. There are no right or wrong ratings, only those that will inform you about the extent to which you may or may not be a good fit for an adult welfare position in Social Services. Record and total your ratings, then compare your score to the ranges at the end of the self-assessment. Should you be contacted for an interview, please bring in your results for discussion.

Instructions: Read and respond to each item using this scale:

1-Strongly Disagree, 2-Disagree, 3-Agree, 4-Strongly Agree

1. I believe I would enjoy working in public adult welfare despite the challenges I may face.
2. I am interested in making adult welfare my long-term professional career.
3. I am committed to seeking a position in adult welfare even though opportunities for a higher salary may exist elsewhere.
4. I believe the personal and professional benefits outweigh the difficulties and frustrations of working in public adult welfare.
5. My personal success in working with clients will not be a significant factor in determining whether I will remain employed in adult welfare.
6. I enjoy collecting and evaluating lots of information to make an informed decision.
7. I am comfortable working with law enforcement and other community partners.
8. I am willing to visit disadvantaged and/or dangerous neighborhoods if my work requires it.
9. I am comfortable knocking on a person's door to initiate contact even though they may be upset by my visit.

10. As an adult welfare professional, I believe I can have a positive and long-lasting influence by helping individuals maintain their dignity and supporting their independence as much as possible.
11. I am willing to complete my casework without knowing what ultimately happens with the person.
12. I realize I may encounter situations that could be better but that do not warrant agency intervention. In those cases, I will be able to close the case and move on.
13. I am willing to testify in court as needed.
14. I am committed to working in adult welfare even though it requires a considerable amount of time to complete required paperwork and case documentation.
15. I am willing to be on call for work during evenings, on weekends, and holidays.
16. I am the kind of person that can handle a lot of ongoing stress and unpredictable situations.

Total your score and compare it to the score ranges and recommendations that follow:

Score range 15-26
