To be considered, nominations are to be submitted to the Department Director by using the Advisory Board Outstanding Community Partner Award Nomination form and submitted by the established deadline. Nominations will be accepted each year from November 1st through December 31st. The Advisory Board will make its selection of the Outstanding Community Partner Award at its first meeting in the following calendar year.

While there will be one nominee recognized for their generous work, other finalists will be acknowledged by the Board as well.



Winchester Social Services supports several adoption initiatives and forums that include recruiting prospective families, conducting home studies, partnering with the courts to feature waiting children, and offering financial assistance and other services that provide stability for adoptive families.

Foster Care Services provide services to children and families in circumstances where the child is to be removed from their home. Foster Care provides a safe and stable environment for children and older youth until the issues that made placement outside the home necessary are resolved. When a child cannot return home, another home is found.
